SUBJECT: NFPA 1991 ROP TCC FINAL Ballot Results (F2011)

The Final Results of the NFPA 1991 ROP TCC Letter Ballot are as follows:

20 Members Eligible to Vote
1 Not Returned (Barker)

PART 1 (TCC Notes)

18 Affirmative
0 Negatives
1 Abstentions (Lumry)

PART 2 (Release of ROP)

18 Affirmative
0 Negatives
1 Abstentions (Lumry)

There are two criteria necessary to pass ballot [(1) affirmative $\frac{3}{4}$ vote and (2) simple majority].

- (1) The number of affirmative votes needed for the proposal/comment to pass is 14.
(20 eligible to vote - 1 not returned - 1 abstentions = $18 \times 0.75 = 13.5$)
- (2) In all cases, an affirmative vote of at least a simple majority of the total membership eligible to vote is required. This is the calculation for simple majority:
[20 eligible $\div 2 = 10 + 1 = (11)$]

According to the final ballot results, all ballot items received the necessary $\frac{3}{4}$ required affirmative votes to pass ballot.
