SUBJ: Meeting Notice – ROP meeting for NFPA 654

The next meeting of the Committee on Handling and Conveying of Dusts, Vapors, and Gases has been scheduled for **November 15 – 17, 2010 at NFPA Headquarters, Quincy, MA. This meeting will focus on processing the ROP for NFPA 654, which is in the A2012 revision cycle.**

The meeting will start at 8:30 a.m., Monday, November 15th and will conclude by 4:00 p.m., Wednesday, November 17th. The document is currently in the Annual 2012 revision cycle (following the action by the Standards Council and NFPA membership to return the document to committee). No new Public Proposals are being accepted. Attached to this notice as part of the agenda for the meeting are the 57 Public Proposals originally submitted to the A2010 revision cycle call for proposals.

Continental breakfast will be provided each day starting at 7:30.

The agenda for this meeting will be dedicated to review and action on Public Proposals and any Committee Proposals to NFPA 654 so that the Report on Proposals can be prepared for letter ballot of the committee. The Public Proposals submitted to the original A2010 revision cycle closing date are attached.

No block of rooms has been set aside for this meeting, but NFPA rates are available at the hotels in the attached list, which are located in the immediate area of NFPA Headquarters (within 2 – 5 miles). You are responsible for making your own reservations.

Several of the listed hotels provide transportation to NFPA Headquarters. Transportation from Logan Airport to the Quincy-Braintree area for those of you not using rental cars is most efficiently completed using the Logan Express Bus service to Braintree. Buses

depart the baggage level of each terminal every half hour and the travel time is 30 – 45 minutes depending on traffic. The cost of the bus is \$22.00 roundtrip or \$12.00 one way. Several of the hotels provide shuttle service to the hotels from the Logan Express Bus terminal in Braintree. Taxis cost about \$45 – 50 from Logan Airport to Braintree-Quincy area. If you are flying to Providence, it is possible to take scheduled buses to Boston and then you would need to come back out of the city to Quincy-Braintree for your hotel.
