3. Approval of Minutes. The minutes of the March 22-23, 2018 meeting and the May 3, 2018 Web/teleconference meeting were approved and distributed.

4. NFPA 101/5000 First Draft. The actions taken by NFPA 101/5000 Technical Committees during First Draft were reviewed.

- A. The actions taken on the public inputs submitted by HRB-SAC were reviewed. Public comments may need to be developed for business, storage, and industrial occupancies. A further review will be completed prior to public comment closing date.
- B. The actions on tall timber buildings were reviewed. V. Zivras will create a side by side comparison of the proposed NFPA 5000 requirements and the IBC requirements. HRB-SAC is hoping to have a presentation on tall timber during their next in-person meeting.

5. HRB-SAC Priority Subjects.

- A. Occupant evacuation elevators continue to be a priority subject. The committee is still in the process of gathering what information is out there and they are working to identify what knowledge gap they can fill.
- B. Broad topics for public inputs for high-rise buildings under construction were discussed. The task group will continue to work on the public input proposals for the next edition of NFPA 241.

6. Public Education. A. Vastis gave a presentation describing what the public education group does at NFPA. A discussion followed regarding public education messaging that is currently offered by NFPA for people who live in high-rise buildings. While there is a fact sheet available, it is out of date. HRB-SAC is looking at replacing the existing fact sheet with three new ones: one if you are going to buy/rent in a high-rise; one if you currently own/rent in a high-rise; one if you manage a high-rise building.

7. NFPA 285 Presentation. T. Vecchiarelli presented updates to 285. HRB-SAC will continue to monitor the subject but currently isn't working on anything specific.

8. New Business. J. Francis presented his work to the group. A discussion followed on the Leadership in Life Safety Design Concept. This topic was a previously considered by HRB-SAC but nothing came of the discussion. At this time, HRB-SAC will not pursue it.

9. Next Meeting. Nothing has been finalized but the committee is considering a March/April meeting in San Francisco.

10. Adjournment. The meeting was adjourned at by Chair, Jim Quiter, at 12:00 p.m. on Wednesday, October 17, 2018.
